

# **QEN BQRTP Referral Guide Qualified Evaluator Network**

## **Referral Submission**

Point of Contact (POC) submits completed Preliminary Recommendation Assessment, Full Assessment, 90-Day Review or Reconsideration Referral Form and Authorization to the QEN Program for processing.

2

## **Referral Review**

QEN Program reviews the referral to ensure all necessary information is provided. If incomplete, the QEN Program will notify the POC.

# **Assigning a Qualified Evaluator (QE)**

QEN Program assigns a QE (based on location and availability), and schedules as follows:

- <u>Preliminary Recommendation Assessment</u>
   Within 1 business day
- <u>Full Assessment</u>
   Within 5 business days
- 90-Day Review
   Within 14 business days

## **Notification**

QEN Program notifies POC via Notice of Child Interview.

Appointment information to all interested parties

Records to QE

Comprehensive Placement Assessment +

Supporting Documentation

Full, 90-Day Review & Reconsideration

Current documentation not available in facility records.

## **QE Conducts Assessment or Review**

QE conducts Preliminary Recommendation Assessment, Full Assessment, 90-Day Review or Reconsideration at determined location (QE's office, on-site at facility, secured video teleconferencing, etc.).

#### Preliminary Recommendation Assessments include:

- A face-to-face attempt with the child
- Review of the Comprehensive Placement Assessment
- The reasons that support the preliminary recommendation for placement

#### All other Assessments/Reviews include:

- Short-term and long-term mental and behavioral health goals
- Child and Adolescent Needs and Strengths (CANS) assessment (if recommendation is rendered)
- A review of prior treatment records
- Interview with collateral contacts
- The recommendation of the child's treating clinical professional
- An interview with the child (face to face or telehealth)

# **QE Completes Assessment or Review**

QE completes the report and submits to the QEN Program within the following timeframes:

- <u>Preliminary Recommendation Assessment</u> Within 1 business day of evaluation
- All other Assessments/Reviews
   Within 3 business days of evaluation

# **Quality Review**

Manager, Service Operations QEN or designee reviews the QE's report for FL Administrative Rules and DCF compliance.

## **Submission to POC**

QEN Program submits report to the POC within the following timeframes:

- <u>Preliminary Recommendation Assessment</u>
   Within 1 business day of receipt from QE
- All other Assessments/Reviews
   Within 3 business days of receipt from QE

POC distributes the report to all interested parties.
